For many years at Bilbo Law Office we have represented people injured by prescription medications and we are currently investigating or actively pursuing the following pharmaceutical drug claims:

• Benicar – A high blood pressure drug that may cause sprucelike enteropathy; severe intestinal problems.

• Effexor – An antidepressant drug that may cause birth defects and suicidal behavior.

• Fluoroguinolone (Levaguin & Cipro) — Antibiotic drugs that may cause peripheral neuropathy; severe nerve damage.

• Lipitor — A high cholesterol drug that may cause type 2 diabetes.

Onglyza – A diabetes drug that may cause heart failure and pancreatic cancer.

Testosterone Replacement Therapy — A drug for low testosterone that may cause heart attacks and strokes.

• Xarelto – A blood thinner drug that may cause internal bleeding and hemorrhaging.

Zofran — An anti-nausea drug that may cause birth defects.
